ADMINISTRATIVE ORDER 2001- 08

RE: Teen Court Grants - FY-2001 - 2002

WHEREAS the Nineteenth Judicial Circuit recognizes and supports the value of Teen Courts as both an educational and rehabilitative program and whereas the Courts are able to provide financial support to participating schools and as Chief Judge, pursuant to Florida Rules of Judicial Administration 2.050, it is therefore Ordered:

1) The Clerk of the Circuit Court of Martin County shall issue a check from the Martin County Teen Court Trust Fund in the amount of \$10,000.00 payable to the "Martin County High School Teen Court Account". The check shall be forwarded to the Court Administrators Office for presentation to the Martin County School System.

2) The Clerk of the Circuit Court of St. Lucie County shall issue a check from the St. Lucie County Teen Court Trust Fund in the amount of \$8,500.00 payable to the "Ft. Pierce Westwood High School Teen Court Account". The check shall be forwarded to the Court Administrators Office for presentation to the St. Lucie County Schools.
